Autism East Midlands is a registered charity which aims to ensure that opportunities are made available for service users to maintain their individuality, maximize their independence and enhance their quality of life.

# <u>Philosophy</u>

- support to make informed choices and have control of their life.
- promoting independence and developing new skills.

# What is The Sherwood Centre Day Service?

The Sherwood Centre is an Autism Specific Hub operating an extended service Monday – Sunday between the hours of 8.00am -22.00pm, offering a wide range of structured activities specifically focusing on building practical skills for the workplace and independence. We also have a sensory element to the service offering lots of sensory activities, through music and sensory exploring.

Our building is an easy to access building which has generously spacious rooms. We have a unique approach to supporting adults with Autism and Learning disabilities; the nature of our service encourages the individual as much choice and control over their support which is always approached in a person centred way. We are located on an industrial park in Mansfield Woodhouse which reflects the purpose of our work based activities and opportunities.

# What do we offer?

We offer a specialist autism specific, person centred environment, where we can support you and help you to achieve your full potential. Our experienced staff will work with you to develop a bespoke program of activities, tailored to your individual needs and aspirations, within a structured and supportive environment. Within Autism East Midlands we have access to our very own Clinical / SALT services, which are on hand for support and guidance.

We aim to provide stimulation and happiness in a calm and caring environment.

We are proactive in reducing restrictive practices and provide support that enables the individual to express themselves freely, contributing to new ideas and choices for their time within the autism hub and their life journey ahead.

## What will you gain?

Flexible attendance packages from 1-5 days per week will enable you to access the many opportunities on offer at the Sherwood Centre. You will also have the opportunity to access nationally recognised accreditation tailored to your individual learning needs and style. To help you to succeed we will provide specialist support, which will enable you to achieve your full potential.

### The Sherwood Centre Support Team

The service is managed by an appropriately qualified and experienced manager (minimum NVQ level IV).

All staff at the Sherwood Centre has received an enhanced DBS and training appropriate to their role. This includes but is not confined to:

- $\Rightarrow$  Common Induction Standards (new staff)
- $\Rightarrow$  NVQ II (minimum for direct support workers)
- $\Rightarrow$  Autism / Asperger / PDA awareness.

- $\Rightarrow$  First Aid

Training needs and opportunities for further development are identified through supervision and annual appraisal for all staff.

All staff has a professional responsibility to respect the rights of service users, treat them with respect and dignity and protect them as far as possible from danger or harm.

## **Evaluation of Service**

The service is monitored and evaluated by a number of internal & external bodies:
